

Hendricks Power Cooperative has announced that on April 23, 2025, our board of directors completed the annual review of capital credits and approved a general retirement distribution/refund for the year 2004. Members who received service from Hendricks Power during that year should receive a "Capital Credit Retirement" bill credit. This credit will show on the bill received in June.

If I did not receive electric service from the Cooperative in 2004, will I get a capital credit retirement?

Not at this time. The Capital Credit General Retirement distribution/refund will only be made to members who received their electric service from Hendricks Power Cooperative during the year 2004. However, it is important that you keep your member record information updated with us regarding any changes or life events (death, divorce, name change, telephone number, email address, etc.) should your years be retired/refunded at a later date. If any of these events have occurred, please contact us so we can review and update the member record.

Capital Credit General Retirement Announced Board of Directors approves the year 2004

What are capital credits?

Hendricks Power is a Cooperative, owned by its members, it does not technically earn profits. Capital credits are the retained "margins" leftover at the end of a year – basically the difference between operating costs or cost of doing business and the total amount of money collected. This capital allows Hendricks Power to finance operations and construction.

Help Avoid Late Fees with Secure Payment Options Amid Postal Delays

Hendricks Power Cooperative wants to make members aware that we are seeing delays in receiving member payments due to ongoing challenges with the postal system. These delays are happening nationwide and are beyond our control.

Unfortunately, this delay results in some payments arriving after the due date, which may lead to late fees.

To avoid these unnecessary fees and ensure your payments are processed on time, we encourage you to consider using one of our reliable, secure payment options that do not rely on the mail:

Secure Payment Options

(\$) Autopay

Payments are automatically deducted each month from your checking account, debit or credit card. You'll still receive a monthly statement indicating "Do Not Pay". To enroll, visit our website or call our office. Disclaimer: Autopay funds will be deducted on the business day before payment is due.

Payment by Phone

We accept payments by checking account, debit or credit card through our automated phone system at (317) 745-5473.

We appreciate your understanding as postal delays continue and encourage you to take advantage of these secure payment options to avoid any service interruptions or late charges.
