- Applicant must provide proof of purchase for qualifying Smart Thermostat purchased at a retailer from January 1, 2020 to December 31, 2020.
- Applicant agrees that Smart Thermostat will remain installed for a minimum of two years.
- Hendricks Power reserves the right to inspect the Smart Thermostat, with notification.
- Rebate is limited to purchase price.
