CAPITAL CREDITS

Giving Credit Where it's Due!

It's time for you to get the credit – capital credits – that you deserve for helping build and sustain our cooperative. In April our board of directors completed an annual review of capital credits and approved a general retirement distribution/refund for the years of 1993–1995. Members who received service from Hendricks Power during those years should receive a capital credit check from the cooperative in mid–July 2019.

What are capital credits?

Because Hendricks Power is a Cooperative owned by its members, it does not technically earn profits. Capital credits are the retained "margins" leftover at the end of a year – basically the difference between operating costs or cost of doing business and the total amount of money collected. This capital allows Hendricks Power to finance operations and construction.

If I did not receive electric service from 1993-1995 will I get a refund?

Not at this time. Capital credit refunds will only be made to members that received electric service from the cooperative during the years 1993–1995. However, it is important that you keep your information updated with us regarding life events and contact information, should your years be retired/refunded at a later date. If any of these events have occurred, please contact us so we can update the member record.

What happens to the capital credits of a member who is deceased and ownership is now within an estate?

If a member from that time period is deceased and ownership is now within an estate, the capital credits can be paid to the representative of the estate.

Please call our Capital Credit Team and they will locate the member record, update the information and discuss the process with the estate representative so a claim can be filed.

Giving Back to our Community



Hendricks Power Cooperative, partnered with CoBank's Sharing Success grant, recently donated \$11,000 to local nonprofits in Hendricks County.

One of the two organizations that received assistance was Sycamore Services, a Danville organization that uses individualized training and services to increase independence in individuals with disabilities and other challenges. Established in 1958, Sycamore Services has played a vital role in Hendricks County.

Hendricks Power, along with the Sharing Success match, was able to contribute \$7,000 to Sycamore Services. These funds

will go toward enhancing its Sensory Garden located at the Danville Annex location. Plans include the installation of wheelchair accessible pathways, terracing with plants and other sensory materials, along with a gazebo/shelter with a metal roof. "The Sensory Garden enhances our program offerings and provides the individuals we serve with new, meaningful opportunities to appreciate nature and have a peaceful space where they can enjoy gentle sensory stimulation," said Patrick Cockrum, CEO of Sycamore Services. "We are excited to be able to move forward with the next phase of this unique garden space that enhances the beauty of Sycamore Lane. We sincerely appreciate the generosity of Hendricks Power Cooperative and their commitment to improving lives in our community."

The next local organization that received assistance was the Hendricks County Senior Services. Its mission is to help older adults live independent, healthy, active, engaged, creative and fun lives. The \$2,000 donation and matching \$2,000 grant will be used toward making repairs to its parking lot. This will include paving improvements needed for safety precautions.

"Hendricks County Senior Services is grateful to Hendricks Power and CoBank for their generous support of this project. The parking lot is not a 'glamorous' location, but we have hundreds of visitors each day and it needs to be a safe space for everyone," said Marina Keers, Executive Director of Hendricks County Senior Services. "The Senior Center is a vibrant and welcoming place and we are so thankful for the investments to ensure we can continue to meet the needs of Hendricks County."
