

## **Capital Credit Payments Made** to Members

Hendricks Power Cooperative has announced that in late March, our board of directors completed an annual review of capital credits and approved a general retirement distribution/refund for the years of 1999-2000. Members who received service from Hendricks Power during those years should receive a capital credit check from the cooperative. Checks were mailed April 30, 2021 and are valid for

#### What are capital credits?

90 days.

Because Hendricks Power is a Cooperative owned by its members, it does not technically earn profits. Capital credits are the retained "margins" leftover at the end of a year - basically the difference between operating costs or cost of doing business and the total amount of money collected. This capital allows Hendricks Power to finance operations and construction.

#### If I did not receive electric service from 1999-2000 will I get a capital credit distribution?

Not at this time. The Capital Credit General Retirement distribution/refunds will only be made to members receiving their electric service from Hendricks Power Cooperative during the years 1999-2000. However, it is important that you keep your member record information updated with us regarding any changes or life events (death, divorce, name change, moving, telephone #, etc.) should your years be retired/refunded at a later date. If any of these events have occurred, please contact us to review and update the member record.

# **MORE RELIABLE POWER IN 2021** & BEYOND

Hendricks Power, along with Wabash Valley Power Alliance, is currently working on enhancements that will improve system reliability, increase capacity, and improve switching capability throughout the northwest portion of our service territory.

This project, known as the Jackson Township - Heritage Lake - Montclair (JHM) Project, involves building a new substation known as Jackson Township Substation in Putnam County and connecting it to the electrical grid by constructing two new 69 kV transmission lines, known as the North Line and South Line. The North Line will extend 6.8 miles from the existing Montclair 69 kV Substation in Hendricks County to the new Jackson Township Substation. The South Line will extend 8.4 miles from the existing Heritage Lake 69 kV Substation in Putnam County to include the new Jackson Substation.

This expansion will have automatic switching capability in the event of

a transmission outage. The project will also enable Hendricks Power to perform feeder switching without having to "blink" members.

Project planning began in 2017 and progressed to route selection design in 2018. Transmission and substation construction began in the fall of 2020 and is scheduled for completion in fall of 2021. Currently, the transmission line between Jackson and Montclair Substations is under construction, and the line between Jackson Township and Heritage Lake will begin later this spring.

JUST BECAUSE YOU WORK IN AN OFFICE DOESN'T MEAN YOU MIGHT NOT BE EXPOSED TO ELECTRICAL HAZARDS.

#### WATCH FOR...

- Electrical cables that are frayed, loose, or have exposed wires.
- Outlets that are worn and won't hold plugs snugly.
- Electrical equipment that gives off a strange odor.
- Overheating equipment. Beware of discolored plastic casings on the equipment or discolored outlet covers.
- Overloaded outlets or extension cords.
- Equipment that is not working properly.

#### TO MINIMIZE HAZARDS:

- Switch off and unplug appliances when they are not in use and before cleaning.
- Turn off all appliances at the end of the day.
- Do not force a plug into an outlet if it does not fit.
- Do not run electrical cords through hightraffic areas, under carpets, or across doorways.
- Make sure the electrical load is not too much for any circuit, even when using a surge protector.
